

## State Mandates

Health screenings that are required by the Commonwealth of Massachusetts for children to attend school include:

## Physical Examinations

Kindergarten entrance,

Sports, Grade 4 , 7 and 10, and new entrants.

## Immunization

New students entering the Fairhaven Public School System are required to be in compliance with the Massachusetts Department of Public Health Immunization regulations.

Heights, Weights, BMI, Vision, Hearing and Dental      Grades K-5, 7, 10

SBIRT      Grades 7 and 9

Postural Screening      Grade 5 - 9

Lead Screening, Kindergarten entrance

Preschool vision screening, prior to kindergarten entrance

## Role of the School Nurse

- To promote optimum level of wellness for students and staff.
- Refers students and families to primary care providers and appropriate community health agencies.
- Provides acute and emergency care.
- Provides health education and counseling to prevent disease and promote healthy lifestyles.
- Conducts mandated vision, hearing, growth and postural screenings and provides follow-up and referral.
- Manages care of children with special needs.
- Manages and administers medication.
- Provides programs and classroom presentations on prevention and control of disease and other health matters, including dental health.
- Maintains confidential, computerized records for all students.
- Ensures compliance with state's mandated immunizations policy for the entry into school.

## Fairhaven School Department

### Sick Child Recommendations

Children must remain at home if they have any of the following:

- If they do not have all required immunizations mandated by DPH.
- A contagious illness such as chicken pox, flu or strep throat; a fever that causes chills, sweating and muscle aches; or a fever over 100 within the past 24 hours. May return to school after on medication or antibiotics for at least 24 hours.
- Red or pink itchy eyes with crusty and/or green/yellow drainage. May return to school when no drainage and/or on medication for a full 24 hours.
- A rash of unknown cause; May return to school when doctor authorizes.
- Head lice or nits (eggs); May return to school when appropriate treatment has been completed and child has been checked by the school nurse upon reentry to school.
- Vomiting or diarrhea: May return to school if 24 hours after last episode.

*This list is a guideline. The School Nurse reserves the right to dismiss students who, in his/her professional opinion, are possibly contagious or are too ill to be in school.*

### Medications and Emergencies

- All medications given at school need a doctor's order. Forms are available at the School Nurse's office or at [www.fairhavenps.org](http://www.fairhavenps.org)
- No child may carry medications to and from school. Medications must be brought to the Nurse's office in the original prescription bottle by an adult.
- If the child becomes ill at school, the nurse will call the parent to make arrangements to take the child home.
- Parents are asked to notify the school nurse immediately in the event of a contagious disease, so that the teacher and school nurse can take the necessary steps to protect the health of the other children.
- Parents are required to complete the student health and emergency information form each year. Parents are responsible for the school having emergency contact numbers.
